How to participate

To make the AGM as accessible as possible to all of our Shareholders, we are pleased to offer Shareholders the following ways to participate in the AGM.

1. Online

- 1. Logon to <u>https://agmlive.link/CCX21</u> from your desktop computer, mobile or tablet device at least 15 minutes prior to the scheduled start time for the AGM. You will need internet access.
- When you log onto the online platform, you will need to provide your details including your Shareholder Reference Number (SRN) or Holder Identification Number (HIN) - to be verified as a Shareholder (available at the top of the proxy form).
- 3. Proxyholders will need their proxy code, which Link Market Services will provide via email no later than 24 hours prior to the AGM.

(b) Via mail, fax or hand delivery

- 1. Complete the enclosed Proxy Form. Instructions are detailed on the Proxy Form.
- 2. All Proxy Forms must be received no later than 10.00am (AEDT) on Monday 15 November 2021 to be valid.
- 3. Proxy Forms may be returned by fax, mail or hand delivery by following the instructions in the Proxy Form.

How to ask a question

Shareholders will be able to submit questions in writing online during the AGM by following the instructions set out in the Virtual Meeting Online Guide. Shareholders may also submit questions prior to the meetings through the Company's Share Registry's website at <u>https://investorcentre.linkmarketservices.com.au/Login/</u>.

In addition, Shareholders will be able to ask questions by telephone during the AGM. Shareholders who wish to ask questions by telephone must contact the Company's Share Registry, Link Market Services on +61 1800 990 363 (Australia and International) from 8 to 15 November 2021 to request a personalised PIN and the applicable telephone number which they will need in order to ask a question by telephone during the meeting. Please review the information about participating in the AGM. If your holding cannot be verified by the moderator, you will attend the AGM as a visitor and will not be able to ask a question.
